## RAJASTHAN STATE ELECTRICITY BOARD

### OFFICER'S SERVICE REGULATIONS, 1974

#### PREAMBLE :

In exercise of the powers conferred under section 79 (c) of the Electricity (Supply) Act, 1948 the Rajasthan State Electricity Board, makes the following Regulations relating to the recruitment, appointment and promotion of officers in the Rajasthan State Electricity Board (except Engineers).

#### PART—I

#### GENERAL

#### 1. Short Title, Commencement and Application :

- a) These Regulations may be called the Rajasthan State Electricity Board Officers' Service (Recruitment, Promotion and Seniority) Regulations, 1974.
- b) These Regulations will come into force with immediate effect. However, the existing vacancies, in any, of these cadres would be filled in as per the practice prevailing upto now.
- c) These Regulations shall apply to all Officers of the Rajasthan State Electricity Board except Engineers, whose service conditions
