## ORDER

**Subject:- Amendment in the list of Empanelled Private hospitals under Rajasthan Rajya Vidyut Pensioners Medical Concession Fund Scheme-2000.**

The Board of Trustees of RRVPMCF Trust in its 20<sup>th</sup> meeting held on 10.01.2017 decided that w.e.f. 01.04.2017 "the reimbursement of medical expenses to pensioners/retirees under RRVPMCF Scheme shall be allowed only for those hospitals which are approved by the Finance Department, Govt. of Rajasthan under Rajasthan State Pensioners Medical Concession Scheme-2014".

Henceforth any extension of validity/addition/deletion/suspension of private hospitals made by Finance Department, GoR shall automatically be affected accordingly on RRVPMCF Trust from the date as mentioned therein or otherwise from the date of issue of order by Finance Department, GoR.

List of Private empanelled/approved hospitals is at "Annexure-A"

List of Referral Hospitals is at "Annexure-B"

Reimbursement of medical expenses on treatment taken in Referral Hospitals outside the State shall be followed by the Rule no. 10 of Rajasthan Civil Services (Medical Attendance), Rules-2013.

This order is in supersession of all previous orders issued for empanelment of private hospitals within & outside the State of Rajasthan.

The order will come into force w.e.f. 01.04.2017.
